

Cotton Valley Rail Trail Club OHRV Registration Information

All CVRTC club members must obtain New Hampshire OHRV registrations to operate on the designated recreational rail trails in the state. The State of New Hampshire has required OHRV registration for railroad motorcars since the club received a letter from the Bureau Chief in 2001.

Individuals may register at any of the OHRV registration agents located throughout the state and must apply in person. Registrations may be purchased at Fish and Game headquarters or through the mail by contacting Fish and Game directly at 603-271-4300. You may also call Fish and Game to find an agent near you. It is important to note that we are in the "Wheeled Vehicle" category. The club is also affiliated with the NH Off-Highway Vehicle Association (NHOHVA). Wheeled vehicle registration fees are discounted for members of NHOHVA. In order to ensure you get your discount, you must get your NHOHVA voucher from the CVRTC NHOHVA Administrator **BEFORE** you register your motorcar. The current administrator is listed below:

When registering ask the agent to check off: **RESIDENT OTHER \$58**

CVRTC members who live out of state: **NON RESIDENT OTHER \$77**

You will need the following information to register your car:

- Drivers License
- Your D.O.B. and address
- Motorcar year of manufacture
- Make, Model and Color
- VIN number/Serial number/Engine number
- Engine Displacement:
ROC/ODB: 44 cu. in. **Onan:** 49.8 cu. in. **Woodings** OH160/27 cu. in. OH180/30 cu. in.

Follow the instructions for OHRV decal placement below. Although railroad motorcar decal placement is not shown below, it gives some idea where to put the decal. It must be **VISIBLE**. Most motorcar owners place them on the front of the car. Maintenance cars do not need OHRV registrations.

DECAL PLACEMENT INSTRUCTIONS

IMPORTANT: Both the decal and the surface to which it is applied **MUST** be warm at the time of application. The surface to which the decal is affixed must be clean and dry. In cold weather a hair dryer works well to warm the surface. As a minimum, warm the surface with your hands, sun, or other means.

No person shall operate any OHRV or snowmobile unless the assigned OHRV or snowmobile registration numbers, plates, or decals are placed on the OHRV or snowmobile as required by law.

ALTERATION OF DECALS IS PROHIBITED.

FAILURE TO DISPLAY DECALS PROPERLY MAY RESULT IN A VIOLATION



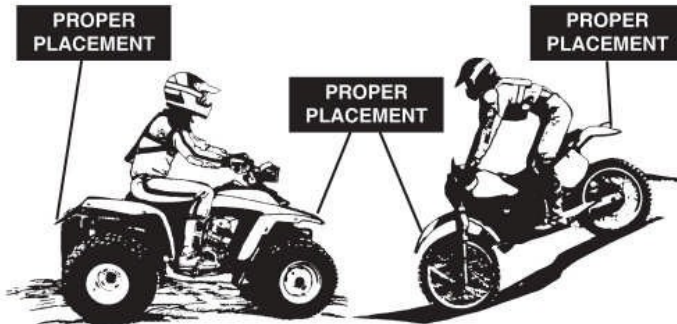

SNOWMOBILE DECAL PLACEMENT

(a) Pursuant to RSA 215-C:36, V and IX, no person shall operate a snowmobile unless the registration decal is attached, by the registrant, to the vehicle as follows:

- (1) Decals shall be placed on each side of the snowmobile cowling or on the outside of the windshield;
- (2) Decals shall be placed so that both are clearly visible and not obstructed; and
- (3) The lower edge of each decal shall be parallel with the ground.

(b) No person shall place an altered registration decal on a vehicle.

OHRV DECAL PLACEMENT

(a) Pursuant to RSA 215-A:21, V and VI, no person shall operate an OHRV unless the registration decal is attached, by the registrant, to the vehicle as follows:

- (1) The registrant shall place one decal on the front fender and one decal on the rear fender, or at locations provided by the manufacturer; and
- (2) The registrant shall place decals so that they are clearly visible and not obstructed.

(b) No person shall alter a registration decal on a vehicle.
